## **Commission Work Programme 2016: No time for business as usual**

- Reaffirming the 10 priorities of the Political Guidelines, i.e. the Juncker Commission's political contract with the European Parliament
- VP Timmermans: "One year ago this Commission made a new start, committing to focus on the big things where citizens expect the EU to make a difference. Today we are taking the next steps to deliver on these political priorities. (...) This is no time for business as usual: citizens will judge the EU on whether it delivers results on the major challenges facing our societies today."

## **New Start for SD: follow-up activities**

- Political meetings on key Commission initiatives
   Meeting with VP Katainen on Investment Plan (April 2015)
   Meeting with VP Sefcovic on Energy Union (June and November 2015)
   Meeting with VP Ansip on Digital Single Market (February 2016)
- LV pres. events + Informal EPSCO on social dialogue
- March/October Tripartite Social Summits
- Dedicated hearings on key policy initiatives: Integration of long-term unemployed (April 2015) Mobility package (June 2015) Skills agenda (January 2016)
- Formal Consultation of social partners (cf. Art. 154) Information and consultation of workers (April 2015) Work-life balance (November 2015)
- Creation of 2 thematic groups to substantiate the commitments and to monitor the follow-up



## **Sectoral dimension of the new start**

- 1) Needs and gaps in terms of capacity building?
  - Legal advice, analytical capacity, institutional framework, mutual learning...?
  - Membership, representativeness, mandate, reaching out to missing sectors...?

#### 2) Relevance for the European Semester?

- Sectoral dimension vs. more focussed CSRs...?
- Specificity of collective bargaining in CSRs and EG 7...?
- 3) SSDC priorities and outcomes?
  - Interconnectedness between SSDCs and EU institutions work programmes...?
  - Relations between sectors, emergence of new themes...?

#### 4) Design and implementation of agreements?

- Rationale and added-value, evidence base...?
- Mutual learning activities, peer reviews...?





## **Informal WG on communication - Objectives**

- Improve visibility of the EU sectoral social dialogue and its outcomes
  - on political level (European and national)
  - towards general public (e.g. EU citizens, civil society)
  - targeted stakeholders (e.g. national SPs, third parties)
- Improve information exchange among SSDCs and between social partners and COM





# Message 1: Social partners are different from civil society





- Informing the EU institutions about the specificity and added value of social dialogue by means of social media, joint opinions, joint recommendations, meetings etc.
- Making national governments of the MSs (in particular CEE countries and candidate countries) aware of specificity of social dialogue
- Fostering more regular exchanges with Member States in Brussels or at the national level with national authorities





#### Actions (to be) taken by the Commission services

- High level meeting on new start social dialogue
- Reinforced coordination within Commission
- Internal trainings
- FAQ for internal COM use
- Connection between COM representations and European Semester Officers with national SPs





# Message 2: Social Dialogue Produces Results





- EU and national social partners inform the general public about SD outcomes (e.g. sectoral weeks)
- Organise SD projects and initiatives in MSs (e.g. joint Cross-Border Observatory in the TAW sector)
- Inform national governments about the outcomes of EU social dialogue





#### Actions (to be) taken by Commission services

- Update of Brochure on EU social dialogue and its translation in all EU languages
- Update of the SD website EUROPA with animation explaining social dialogue
- Explore possibility of "Newspage" on social dialogue themes with regular spotlight and inclusion in the DG EMPL newsletter





# Message 3: EU Social Dialogue is relevant to you





- Informing national SPs about the outcomes of EU social dialogue by means of national workshops/round tables, follow-up meetings (both with national SPs as well as companies), information/promotion material, toolboxes etc.
- Support national members in SSDC in their communication efforts towards their own constituency
- Communication strategy should be discussed in the relevant SSDC at least once per year
- Inclusion of communication in the joint work programmes (e.g. exchange of experience in the SSDC)
- Taking the opportunity of the tripartite nature of EU agencies (OSHA, Eurofound, CEDEFOP) and ILO to raise awareness on SD outcomes





# Message 4: Good communication requires internal communication





- Improving communication between sectoral social partners (within their respective umbrella organization or other types of informal networks)
- Improving communication between different SSDCs





#### Actions (to be) taken by Commission services

- Standing agenda item at the Liaison Forum(s) should:
  - evaluate communication activities by COM and SPs
  - Allow social partners /SSDC to present best practices
  - identify upcoming communication opportunities
- Explore possibility of "Spotlight" on social dialogue outcome on EMPL website - e.g. newsfeeds, social media feeds etc.
- Survey on opportunity of 'newsletter'




