SECTORAL DIALOGUE COMMITTEE POSTAL SERVICES

Minutes Plenary meeting 13 November 2020

Due to the specific context of COVID-19 pandemic, the meeting took place through videoconference.

The meeting was held with the new version of the interactio system; it was very unstable. The interpreters faced difficulties because of issues with the sound. Some participants had problems with their connection and/or presentation because of the quality of their connection or headsets.

1. Opening of the session

Jurgen Joos (DPDHL) Interims-Chair Social Dialogue Committee Post Deutsche Post DHL Group, chaired the meeting. Mr José Oliveira (SNTCT) was the vice-chair. Both chairpersons were confirmed for the next 2 year term.

Minutes of the last meeting and draft agenda were adopted.

2. Update on initiatives related to the postal sector

Mr Jean-Yves Muylle, Head of Unit for the "Public Interest Services" unit in DG GROW, presented an update of the main EU initiatives related to the postal sector (slides attached).

The ex-post evaluation on the Postal Services Directive is being carried out. The public stakeholder consultation on the evaluation was open until 9 November 2020; the replies are being analysed and will be taken into account in the preparation of the evaluation.

The targeted consultation on the implementation of the Regulation (EU) 2018/644 on crossborder parcel delivery services was open until 15 November 2020. The replies are being analysed, including responses from the social partners and their members at national level, who were invited to take part in the consultation.



Following a number of questions from participants, Mr Muylle clarified that the broad impacts of the COVID-19 crisis on the postal market will also be taken into account in the evaluation of the Postal Services Directive. Moreover the European Regulators Group for Postal

Services, which is an advisory group of the Commission, is collecting information about the measures taken by the postal sector as a result of the coronavirus outbreak and the operational impact of the pandemic at Member State level. For the evaluation it will be important to identify the causality link between impacts which are due to the Directive, and those which are due to external market developments.

The adoption of the ex-post evaluation on the Postal Services Directive and the implementation report on the Regulation on cross-border parcel delivery services are foreseen for the 2nd quarter 2021. As the evaluation on the Postal Services Directive was already announced in the updated 2020 Commission's Work Programme, it is not mentioned again in the 2021 CWP.

3. Presentation of social partners Joint Statement on the Postal Services Directive (PSD)

Katharina Kronenberg (DPDHL) presented the Joint Statement adopted by the social partners in the context of the consultation on the review of the Postal Services Directive¹. The statement is based on the joint contribution adopted last year; it recalls notably the request to the regulators to maintain the focus on the Universal Service Obligation (USO).

Margaux Meidinger, chair of the PostEurop Social Affairs Committee (SAC), highlighted the good internal cooperation on the employers' side, the HR experts and the regulatory experts of postal operators. The Joint Statement is aligned to the answer of PostEurop to the consultation on PSD. She stressed the good cooperation with UNI and CESI and recalled the importance of fair working conditions and social dialogue.

Dimitris Theodorakis, UNI Europa, indicated that the trade unions were very pleased about the adoption of the Joint Statement and its focus on the USO. UNI is looking forward to engage with the Commission for future work.

CESI was also fully involved and is happy with the negotiation process.

The social partners virtually signed the Joint Statement. Request for its translation will be sent to the Commission.

The Chair thanked the social partners for the good cooperation.

4. EU development regarding digital skills

Alexander RIEDL from DG CNECT presented the EU developments regarding digital skills.



He encouraged the social partners to use the opportunity offered by the Recovery and Resilience Facility (RRF) to benefit from funding for skilling and re-skilling. Social partners can contact the Member States authorities in order to be included in their National Reform Programmes.

5. Training, Health & Safety WG Activities update

Dimitris Theodorakis on behalf of Barbaro Francesco Costa, chair of the Training, Health and Safety working group, up-dated on the implementation of the project 'Postal Skills and Work Environment in the Digital Era'. The project focuses on two key topics, anticipation of skill needs and impact of digitalisation on the working environment.

Questionnaires on three occupational profiles (back office postal operations, delivery of postal items with particular focus on e-commerce, post offices networks) are in preparation and the questionnaire on the first occupational profile has been sent out; replies to be sent to E&Y contractor (see slides).



Margaux Meidinger stressed the importance of the project for successful digitalisation and asked to answer the questionnaire carefully.

6. COVID-19

George Papasteriades provided an up-dated about the COVID-19 situation in the EU and the set of actions in the postal sector (see in the above slides).

Jurgen Joos presented DPDHL COVID-19 containment and prevention measures.

• Postal Sector Evolution WG update – presentation of the funding demand for the new project.

Margaux Meidinger, chair of the Working Group on Postal Sector Evolution (PSE), presented the objectives of the new project submitted in 2020 under the European call for proposals to support social dialogue. This project is the follow-up to the five scenarios, jointly developed in the previous PSE project. It will focus on the evolution of specific postal jobs in the context of the 5 scenarios.

Commission's decision on the funding demand is expected before the end of 2020 (to be confirmed).
