


Highlights from the Working Groups 2014-2015

- 31 October 2015: end of mandate
- 30 November 2015: publication of **the Highlights,** a presentation of **key outputs and policy messages**
- Drafted by the Commission in cooperation with Working Group members
- These messages do not necessarily reflect the Commission nor the Member States' positions, but are intended to summarise the main conclusions of the informal work undertaken in the Groups



#### New mandate

- (1) **Relevance**: strengthening societal and labour market relevance at all levels of higher education (Priority Area 1.vi).
- (2) **Innovation**: within a broad concept of innovation, building partnerships through interdisciplinary and inter-sectoral approaches enhancing regional development and the knowledge triangle through closer links between higher education, research and innovation, optimising opportunities offered through open and digital education (Priority Area 3.i, iii and v).
- (3) **Inclusion**: supporting the social engagement of higher education institutions, improving the transition from secondary to higher education, promoting intercultural and civic competences of students, promoting a diverse student body including by tackling gender gaps, and integrating newly arrived migrants (Priority Area 2.i and iv).
- (4) **Teaching**: promoting quality teaching and pedagogical training and ensuring that teaching is seen as comparable to research in academic careers. (Priority Area 4.iv).
- (5) **Internationalisation**: promoting internationalisation, recognition and mobility (including through joint programmes, cross-border higher education, internationalising curricula, etc.) to enhance quality and innovation potential (Priority Area 5.i, iii and iv).

**Sustainable investment and governance**: focussing on effectiveness by examining performancebased funding and system governance and leadership - ensuring higher education systems are structured, governed and funded in a sustainable, future-oriented way (Priority Area 6.iii).



### **Reviewing the modernisation agenda**

- Consultation process with Member States and stakeholders now underway
- Linked to Skills Agenda in May/June 2016
- Renewed policy framework by late 2016
