1. Welcome and adoption of the draft agenda

  - a. Project selected by the Commission, partners associated ECA lead, ETF, ERA ECA explained that AIRE was not willing to be member of this consortium due to lack of capacity
  - b. AIRE asked to be informed about the study
  - c. The project will start in Feb. 2019

# **3.** Information on applications for membership to the Social dialogue committee

- a. The participants were informed about the state of play regarding the applications of ACP, A4D and EurCCA to become members of the SSDC.
- b. ECA will inform A4D about their position

### 4. Temporary Agency Mobile Workers in Aviation: scope and next steps

- a. ECA presented a draft internal paper circulated the day before the meeting
- b. Employers indicated that they had no time to analyse the paper. After a quick reading they see a need to clarify the scope and purpose and the amplitude of the issues described

c. ECA will circulate a revised paper as a basis for the airlines to consult their members about the practices described
