

# « Posting » DB – Phase II

## Structure/content of national reports :

1. Mandatory declarations
2. Minimum wages, including overtime and night work
3. Wage supplements and allowances (housing, meals, transportation,...)
4. Maximum working time and minimum rest
5. H&S rules
  - Collective
  - Individual
6. Minimum paid annual holiday
