- Agenda item 3: In particular, the following amendments will be the focus of the debate:
 - "A competent Union institution or body, in cooperation with the competent authorities in the Member States, airport operators and social partners, shall set ambitious and binding minimum standards to ensure the highest quality of education and training for employees in the groundhandling sector... " (amendment 334)
 - "The competent authorities of the Member States, in cooperation with the airport operators and social partners concerned, shall determine details for additional airport-specific training, as well as the frequency and the minimum duration of such training...." (amendment 335)
 - "The specific content of the tests and courses and their proper conduct shall be harmonised at European level..." (amendment 336)
