



TRACES Implementation





- ✓ Food chain control digital strategy: a new vision of exchanges
 - Full dematerialisation of veterinary, phytosanitary certificates for importation and for intra EU trade, border control Documents, COI (Organics certificates), FLEGT (timber certificates) and Fish Catch certificates
 - Dematerialisation of the sanitary control and movement procedures (Border control, intra EU trade)
 - Dematerialisation of the border clearance process: EU Customs Single Window





✓ Original document = electronic form

- "[...] writing in electronic form is admitted as evidence in the same way that written it on paper, subject to properly identify the person lodging it and that it be prepared and kept in conditions such as to ensure the integrity"
- E-sanitary certificate will have the same legal validity than a paper sanitary certificate
- Digital signature





- ✓ Legal framework and paperless sanitary procedures
 - Since 2005: Regulation on TRACES to make it compulsory for intra EU movements and import of animals and products of animal origin
 - Since July 2016: Regulation eIDAS gave a legal value to the e-sanitary certificate without imposing it
 - From 2020 : New Official Control Regulation e-sanitary certificate would be mandatory
 - Official definition of e-sanitary certificate (attributes, forms, etc.) to be specified with delegated acts





✓ A complete end-to-end digital service

- A complete end-to-end digital experience for the all the users, at all stages of food chain control
- Different types of specific use cases adapted for member states or third countries
- Support to use digital services
- New media devices (PC, smartphone, tablet)


TRACES e-sanitary certificate: a regulated offer

- ✓ A digital signature process based on a 3-steps workflow, in compliance with the eIDAS regulation (R (EU) N° 910/2014)
 - Step 1 : Authority Electronic Seal (Issuing Country)
 - Step 2: Qualified certificate of digital signature (same legal value as handwritten signature) (Physical Person Certificate)
 - Step 3 : TRACES seal (EC Seal)
 - + Qualified time-stamping
 - + Archiving of evidence's files

TRACES e-sanitary certificate: an easy and free offer

✓ A common approach for different use-cases

- Technologies and methodology adapted for each types of exchanges (EDI, PDF, uploading of signed PDF)
- A single interface : TRACES
- Limited interaction between MS or non EU countries & EC
 Trust Services Provider
- The possibility to use its own digital signature technologies
- A few simple but mandatory requirements


✓ No charge for MS and non EU countries

 Digital signature technologies = free services - included in TRACES






Electronic signature service for PDF flow






Benefits of the paperless food chain

- Optimize the management of the sanitary certificate
 - Simplify trade Reliable information at each stages of food chain - Reduce multiple copies & duplicates
- ✓ Reduce processing times
 - Pre-notification Replacement -Anticipation of the receipt
- ✓ Simplify & modernise the relations within EU MS and between EU MS and non EU countries
 - An online certification single window
- ✓ Ensure integrity, traceability and legal value of the digital documents
- ✓ Fight against fraud
- ✓ Reduce costs

From farm to fork
