## 7. INITIATIVES OF THE EUROPEAN COMMISSION

Mr Lopes (DG EMPL) informed that the Commission made yesterday, 28 March 2012, the final analysis of the Impact Assessment Report on MSD.

The final adoption of the proposal by the College would take place mid of 2012.

Mr Lopes also informed that the final report on the study on the Carcinogenic Directive was already submitted to DG EMPL.

The report was already discussed in the WG CHEMICALS.

During this year 2012 several meetings will be organised on this issue.

### 8. NEW OSHA CAMPAIGN ON RISK PREVENTION

The Bilbao Agency organised yesterday a partnership meeting in Brussels to present the new OSHA Campaign called "Working together for risk prevention" (2012/2013).

EFBWW already decided to be Partner of this Campaign.

Later on UEA and EFIC will decide if they also participate in this Campaign.
