1. Adoption of the draft agenda

The agenda of the meeting was adopted with one minor adjustment (agenda item on EU convince removed).

2. ESSDE Work programme 2018-2019: discussion and further steps

Social partners reviewed and discussed progress made on each topic mentioned in the work programme.

- 3. Other ESSDE meetings in 2019: selection of themes for the meetings
 - Monday 25/02/2019: ESSDE Working Group on Higher Education and Research
 - Monday 24/06/2019: ESSDE Working Group on selected topics of the Work Programme
 - Monday 02/12/2019: ESSDE Plenary
- 4. Discussion on the Follow up on the "Joint ETUCE/EFEE Declaration Towards a Framework of Action on the attractiveness of the teaching profession" and on the ESSDE capacity building needs
 - Social Partners agreed to work on a new ESSDE project proposal on social dialogue capacity building for 2019-2021. Secretariats will pursue the discussions and work on a proposal for the call for proposals 2019.
- 5. Update and discussion on ESSDE project developments for 2018-2019, joint project priorities for 2019-2020 and division of tasks

- European Sectoral Social Partners in Education promoting effective integration of migrants and refugees in education: project is ongoing. It aims at developing an EU quality framework.
- Lifelong Learning for All: Social Partners in Education promoting quality and inclusive VET to enhance lifelong learning for all: the project is starting now.
- OiRA tool in the education sector: work related to the OiRA tools is back on track.
- Integrated dissemination plan for the OiRA tool in the education sector (2019-2020): Social Partners intend to submit a small project to the 2019's call for proposals in order to disseminate and promote the use of the tools.
- 6. Update on the Eurofound representativeness study: the study is ongoing and should be finalised early 2020.
- 7. General discussion on how we could improve our meetings, communication and implementation of outcomes.

Social partners discussed several ideas to improve their meetings:

- they would prefer to hold meetings on Tuesdays/Wednesdays/Fridays to maximise participation (instead of Mondays/Fridays). Such preference can be specified when asked about the planning for 2020 although this cannot be guaranteed as it depends on the availability of Commission's meeting rooms;
- organise more sub-group discussions if the first experience in the February's working group meeting is successful;
- improve communication with occasional joint video messages (joint conferences, SSDC meetings).
