## REGULATION (EU) 2016/796 (...) on the European Union Agency for Railways

### CHAPTER 3 - TASKS OF THE AGENCY RELATING TO RAILWAY SAFETY

#### *Article 13*

#### **Technical support – recommendations on railway safety**

5. The Agency may issue guidelines and other non-binding documents to facilitate the implementation of railway safety legislation, **including the provision of assistance to Member States in identifying national rules that can be repealed (...)**

### CHAPTER 4 - TASKS OF THE AGENCY RELATING TO INTEROPERABILITY

#### *Article 19*

#### **Technical support in the field of railway interoperability**

3. The Agency may issue guidelines and other non-binding documents to facilitate the implementation of railway interoperability legislation, **including assistance to Member States in identifying national rules that can be repealed (...)**

## Railway Safety Directive (EU) 2016/798, Article 8 (1)

### *NSR Evaluation (I)*

#### Directive (EU) 2016/798, Article 8 (1)

National rules notified by 15 June 2016 pursuant to Directive 2004/49/EC shall apply if they:

- (a) fall into one of the types identified under **Annex II**; and
- (b) comply with Union law, including in particular TSIs, CSTs and CSMs; and
- (c) would not result in arbitrary discrimination or a disguised restriction on rail transport operation between Member States.

## Railway Safety Directive (EU) 2016/798, Annex II

### **National safety rules notified in accordance with point (a) of Article 8(1) include:**

1. rules concerning existing national safety targets and safety methods;
2. rules concerning requirements in respect of safety management systems and safety certification of railway undertakings;
3. common operating rules of the railway network that are not yet covered by TSIs, including rules relating to the signalling and traffic management system;
4. rules laying down requirements in respect of additional internal operating rules (company rules) that must be established by infrastructure managers and railway undertakings;
5. **rules concerning requirements in respect of staff executing safety-critical tasks, including selection criteria, medical fitness and vocational training and certification, in so far as they are not yet covered by a TSI**
6. rules concerning the investigation of accidents and incidents.

## Railway Safety Directive (EU) 2016/798, Article 8 (2)

### *NSR Evaluation (I)*

### Directive (EU) 2016/798, Article 8 (2)

By 16 June 2018, Member States shall review the national rules referred to in paragraph 1 and repeal:

- (a) any national rule which was not notified or which does not meet the criteria specified in paragraph 1;
- (b) **any national rule which has been made redundant by Union law**, including in particular TSIs, CSTs and CSMs.

### Project 3 – National Rules concerning Requirements on Staff

#### Activity Overview

#### Step 1: Analysis of notified rules (Notif-IT)

- Based on Notif-IT classification:
- 4 areas: selection criteria, med fitness, training, certification
- 7 staff groups: train driver<sup>1)</sup>, train crew, shunter, RSt maintenance, staff moving on track, RID staff, others

#### Step 2: Questionnaire Survey

- Questionnaire to be send to NSA and RB
- Feedback to be submitted 6/2018

#### Step 3: Bilateral discussions

- Supplementing questionnaire feedback
- Clarification and filling remaining information gaps
- Boundaries and responsibilities: EU rules – NSR – RU rules
- National (cleaning-up) strategy, sector views

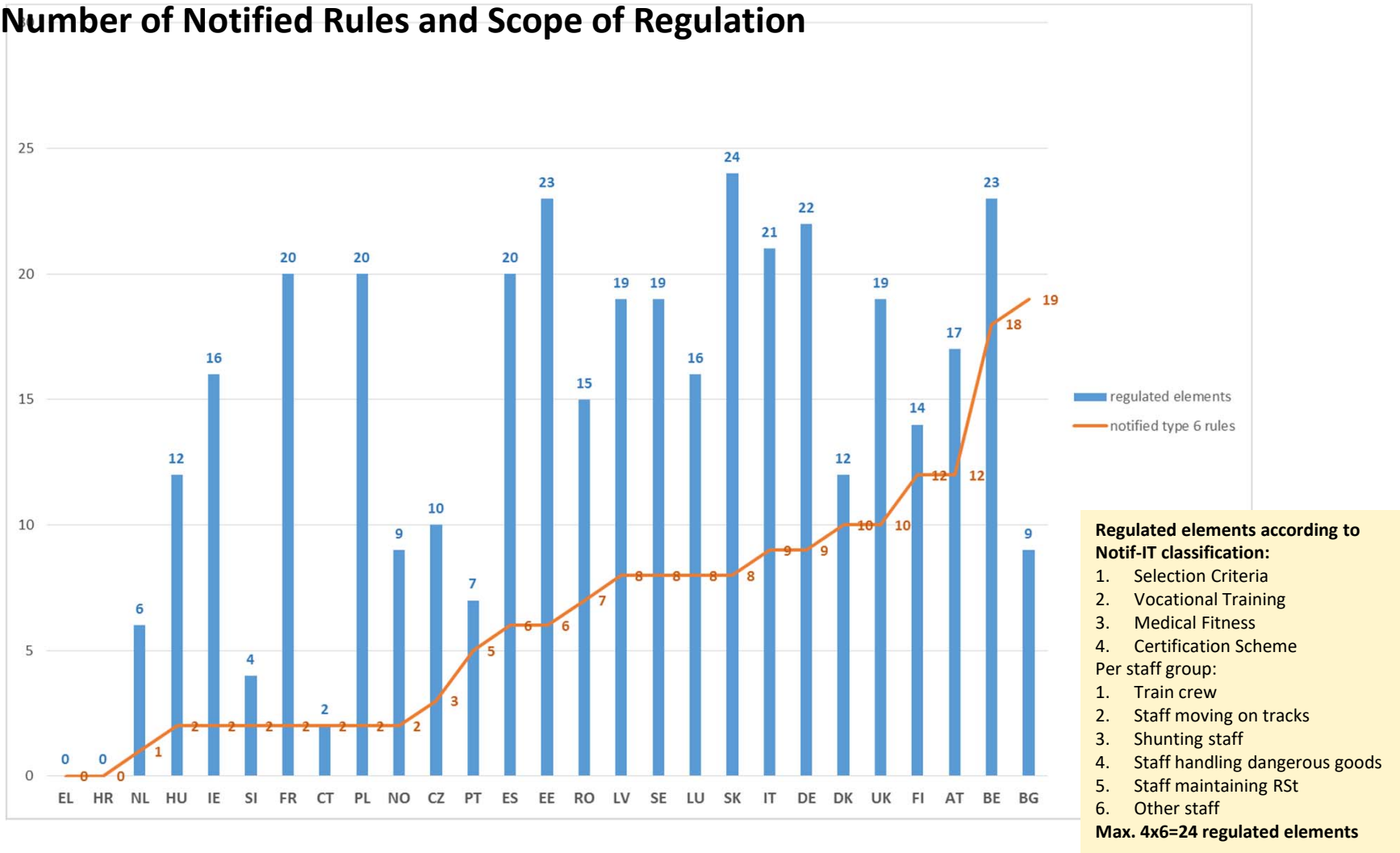

## **Part A: General Questions on Views and Expectations**

To provide overview on the views and positions regarding cleaning-up, harmonisation or keeping of national rules in the area of staff regulation

## **Part B: Rules-Content-Checklist (NSA only)**

Information on the content of rules. Addressed to experts in Ministry or NSA, well familiar with the rules details.

# Questionnaire

## Part A: General Questions on Views and Expectations

### Examples:

Management of staff competence is an important task of the safety management system (SMS). In application of the SMS, companies need to ensure the full implementation of all relevant national rules.

- a) What are the measures, used by the NSA, to monitor the good implementation of national rules within the companies' SMS?
- b) Based on your experiences, are national rules on staff requirements well accepted and applied by the sector?

# Questionnaire

## **Part A: General Questions on Views and Expectations**

### **Examples:**

Cleaning-up of national rules is mandatory, whenever the subject of regulation is already covered by European regulation. Currently, staff related requirements can be found for train drivers in Directive 2007/59/EC and to certain extent for some other operating job tasks in the TSI OPE.

Do you support the idea of harmonising other staff requirements in order to accompany and force the process of reduction of respective national rules?
