Mr Matteo Governatori reports on the recent and ongoing Commission initiatives directly or indirectly related to the fight against undeclared work as well as future steps in this area. (see attachment to the minutes).

On the possible collaboration with the Rockwool Foundation, Mr Jensen (EFFAT) explained that a Rockwool representative was ready to deliver a speech at the next SSD Steering Committee meeting(s) but required payment for time spent on top of travel expenses.

EFFAT and HOTREC will continue working on the issue of undeclared work/illegal working practices..

Both EFFAT and HOTREC have been invited by the Commission to appoint one representative for the Committee of Experts on Posting of Workers. Kerstin Howald announced that she would represent EFFAT in the Committee. Mr Couchman will be representing HOTREC.

# 4. Skills and Qualification Passport

Ms Howald (EFFAT) reviews the last developments.

With regard to the multi-sectoral initiative, the agricultural sector was chosen to present their Agripass to EURES. The collection of information about the other social dialogue committees' initiatives in the field of qualification and training will serve to make clear that there are also other interested sectors.

With regard to the implementation of the QSP, it is agreed to try to present an application before 2 March 2009 under the social dialogue budget line, and that EFFAT shall be taking the lead on the elaboration of the application for a grant. The EFFAT secretariat will work in close contact with the HOTREC secretariat.

Following the technical seminar on 14 March 2008, organized by social partners from several sectors with the support of the European Commission, the sectoral partners involved decided that more detailed information on experiences and good practices is necessary before discussions can start about possible social dialogue instruments, and launched a multi-sectoral research project to gather further information on how sectoral social partners at the national, regional and local level are tackling the issue of third party violence at the workplace.
