



**NOTICE OF WITHDRAWAL OF A NOTIFIED DRAFT MEASURE UNDER ARTICLE 7 OF  
DIRECTIVE 2002/21/EC<sup>1</sup> AS AMENDED BY DIRECTIVE 2009/140/EC**

**Cases DE/2018/2088 and DE/2018/2091:**

**Retail market of access to the public telephone network at a fixed location in  
Germany – market review and withdrawal of remedies for one sub-market**

- 1) On 14 June and 18 June 2018, respectively, the Commission registered two notifications from the German regulatory authority, *Bundesnetzagentur* (BNetzA), concerning the retail market of access to the public telephone network at a fixed location<sup>2</sup> in Germany.
- 2) By two letters of 13 July 2018, BNetzA withdrew both its notifications for the abovementioned market.
- 3) Pursuant to point 19 of Recommendation 2008/850/EC<sup>3</sup> the notified draft measures are removed from the register.
