If something does not work try changing browser, Mozilla and Explorer visualize Reportnet differently. In some cases the folders include additional information in other formats.

In principle each report should indicate in the title and in the "period" field the year of the reporting exercise (in which the derogations were actually active). In a few reports this approach is not followed.

In some cases there are old versions or wrong reports. The links included in this table are the ones indicated as correct by the national authorities.
