Objectives and actions

- **In relation to item 1**

To follow up the good results of the enlargement project 2008 with a project focusing on 2-3 new countries. The aim is to develop and strengthen social dialogue in these countries as well as integrate the social partners into the European social dialogue
- **In relation to item 3**
To discuss social and employment aspects of relevant regulation and trends in the insurance sector as well as the social partners' role in contributing to good policy-making and good implementation.
