As recalled in the notice to stakeholders of 15 September 2020 on the withdrawal of the UK and EU rules in the field of TRQs, an export licence issued by the UK will cease to be valid where the export of the consignment is effected or ensured after the end of the transition period (31 December 2020).

Therefore, the allocation coefficients applying to export licence applications received under the TRQs open for cheese export to the USA in 2021 have been calculated without taking account of applications notified by the UK. Those allocation coefficients appear in column h of the table 1 below:

NOTA BENE: On 7 October 2020, the EU received a letter from the US announcing that the US will apportion 4 of the above mentioned TRQs, for the year 2021, between the EU and the UK on the basis of historical imports of the relevant products into the USA in 2013-2015. It is therefore likely that the USA will not accept upon import in their territory the full volumes resulting from applying the above mentioned coefficients for the 4 relevant TRQs.

For information and with a view to avoiding complications at the US border table 2 below calculates allocation coefficients as they would result from comparing applications received from the 27 MS with the apportioned quantity for the EU decided by the US:
