Parts of the Project: 1. study

- The project aims to collect information on the European gas sector (**study**)
 - Regarding the age profile of the workforce, skills and qualifications and developments in 15 years time or longer
 - Compare with general labour market analysis for comparison
 - Expectation of general (energy and regulatory) trends of relevance for the European gas sector
 - Scenarios regarding future skill developments

Study part II

- A joint survey of companies and unions
- Indication of scenarios that face the gas industry
 - One method to get more in-depth analysis is through a panel interview method of representatives of the company and workers (trade unions/ workers representatives).
 - Interviews should focus on forward looking management of employment and competencies and how unions and employers are dealing with it.
- Cases will be selected together with the Steering Committee and ideally should be a mix of local and transnational, public and private companies, operating in fully deregulated and less deregulated markets, West and East-European Union countries

Parts of the project 2. Conference

The conference will bring together representatives of the companies and the trade unions to consider the study (and possibly a draft of the toolkit) and selected cases.

The conference will allow the social partners to inform a broader set of representatives of the industry of the work that they are doing.

Parts of the project: 3 Toolkit

The next phase of the project aims to develop a **toolkit** on how companies and trade unions are engaged in long-term planning to respond to the trends.

The toolkit should describe in an accessible manner cases of best practice; and provide guidance to companies and unions focusing on demographic change and competencies.

Time line of the Project

Preparatory phase - **Steering Committees** foreseen for:

- 4 December 2008- discussion, planning, issuing call for tender, process of deciding on the bids.
- 27 January 2009: Steering Committee meeting in Brussels. Deadline for the bids, decision on the company/ person to do the research; possibly already with the researcher.
- 7 April 2009: Steering Committee meeting in Brussels. First draft of report to be discussed; first discussion on Conference.
- 18 June 2009: Steering Committee meeting in Brussels. Final draft version of report; final programme invitations.
- 8 September 2009: Steering Committee meeting in Brussels. Final report discussion on programme; discussion on call for tender second part (toolkit).
