

**SHORT SUMMARY OF CONCLUSIONS OF THE 53RD MEETING OF THE SCIENTIFIC
REVIEW GROUP ON TRADE IN WILD FAUNA AND FLORA¹
14 SEPTEMBER 2010**

The SRG took the following decisions² under Articles 4.1(a)(i) and 4.2(a) of Council Regulation (EC) N° 338/97:

8) ***Swietenia macrophylla* / Nicaragua:** The SRG agreed to allow imports of logs of *Swietenia macrophylla* from Nicaragua that were destroyed by a hurricane in 2007. Nicaragua will be requested to provide information on the quantity of these logs with a view to establishing a monitoring mechanism. All further applications for *Swietenia macrophylla* from Nicaragua should continue to be referred to the SRG

9) ***Varanus yuwonoi* (F) / Indonesia:** The SRG decided not to allow imports of this species / country combination from one specific facility in Indonesia. Additional information can be obtained from the Management Authorities in the EU Member States.

10) ***Anguilla anguilla* - implementation of the listing:** The SRG expressed its deep concerns about the population status of the species, the current levels of fishing and a wide majority of its members was of the opinion that a regime should be

adopted whereby exports and imports of all specimens and commodities would not be allowed.
