

4.7 Segment Group 2 (NAD): NAD - Name and Address

4.7.1 Purpose

This segment is used to transmit the name and address of the organisation sending the message and/or organisation to which the message is addressed. The party must be identified through a party identifier in C082. The parties described in this group are parties relevant to the message as a whole, and not for particular data sets.

4.7.2 Segment Rules

This is the trigger segment of Group 2, and must be present if the group is used.

4.7.3 Relationships

4.7.5 Data Element Rules

3035 - Party qualifier

This defines the function of the party. One of two codes can be used in this element in GESMES for maritime transport statistics:

Code Values:

MS Message sender
 MR Message receiver

C082 - Party Identification Details

This composite is used:

- to refer to an external identifier of the party, which is either issued by an agency identified in the message through elements 1131 and 3055, or understood via bilateral agreement. C058, or C080 to 3207 can be used to complete the identification.
- to transmit, for the future use as a unique reference, an identifier of the party described in C058, or C080 to 3207.

3039 - Party id identification

This contains the identifier of the party. Its use is MANDATORY. The code list should be agreed between the partners.

The following codes have been defined so far, for transmission between CNAs and Eurostat (See appendix one):

The code list will be updated and maintained by Eurostat during the transitional period of the implementation of the Directive on maritime statistics.

1131 - Code list qualifier

Not used.

3055 - Code list responsible agency, coded

The value 142 (Eurostat) should be used.

² This code is used only in the case of Message Recipient for test with Eurostat.

C058 - Name and Address

This is used to transmit, if needed, the name and address of the party, in an unstructured way.

3124 - Name and address line

The first line shall contain only the name (or part of it). The following lines may contain a continuation of the name and elements of the address.

C080 - Party Name

This is used in combination with C059 to 3207 to transmit the address in a structured way.

3036 - Party name

This is the name of the party. The element is repeated if the name is more than 35 characters long.

3045 - Party name format, coded

This specifies the format of the party name - EDCL values only are allowed.

C059 - Street

This is used in combination with C080 to 3207 to transmit the address in a structured way.

3042 - Street and number/P.O. Box

Street and number in plain language, or Post Office Box. The element is repeated if the information is more than 35 characters long.

3164 - City Name

Name of a city (a town, a village) for addressing purposes.

3229 - Country - Sub-Entity Identification

This may be used, if needed, to indicate the coded identification, defined by appropriate governmental agencies, of a geographical area (state, province,...). This is not the postcode (see 3251).

3251 - Postcode Identification

This is a code value designating a postal zone, for addressing purposes.

3207 - Country, Coded

This is a code value designating a country or other geographical entity. International standard ISO 3166 shall be used for the entities it covers (there are some entities missing or grouped, in that standard).
