Treatment of canteen items in the DET

1. INTRODUCTION

For the BH "11.11.12.1 Canteens" no price collection is foreseen. We use an approach taking reference items from the BHs "11.11.11.1 Restaurants services whatever the type of establishment" and "11.11.11.2 Pubs, bars, cafes, tea rooms and the like".

2. CANTEEN ITEMS IN YOUR FINAL COUNTRY LIST

The canteen items are contained in your final country list like normal items. You can add canteen items from other group lists to your list. **But don't forget to add also the source item to your country list.** If you add a canteen item without its source item, you will get problems in the DET. You can find the code of the source item in the description of the canteen item.

As you can see the screen for the canteens reference items looks different as for the other items. The item description just refers to the source item. Except of "Finalise" all buttons have been removed. A new button "Include Item" has been introduced. The price grid has not been removed but it is not possible to type in data there.

Eurostat recommends start working on the canteen items after you finished your intra country validation. Please go through the list of canteens items and check if the items could be used as a reference. If yes click on **Include Item**. All prices from the source item will be copied to the reference item.

In the Price Collectors Mode the reference items for canteens are visible, but the price collector is not able to enter any data and the "Include Item" button is not available. If you export a SUA file in price collector mode we recommend to remove the BH Canteens (DET Manual page 6).
